

TERMS OF TRADE

Valid From 01/04/2018

1. RATES

- (i) All rates are:
Valid for the period of agreement.
Quoted in Australian dollars (AUD).
Inclusive of GST.
Room rates include Tropical buffet breakfast for each paying client.
- (ii) Rates quoted are ONLY applicable for FIT packages, tour series programs and Add Hoc tour group business up to 6 rooms. All room reservations are subject to availability and confirmation by Australian Pacific Lodges Pty Ltd, except when a room allotment is agreed upon by Australian Pacific Lodges Pty Ltd.
- (iii) All rates are applicable only for reservations made directly with Australian Pacific Lodges Pty Ltd.
- (iv) A Group is defined as 12 or more paying guests or 6 or more paying rooms.
- (v) Children are defined as 2-12 years inclusive for packages 3-12 inclusive for meals and accommodation.

2. TAXES/SERVICE CHARGES

Australian Pacific Lodges Pty Ltd reserves the right to adjust the rates stated in this Contract in the event of any alteration to Federal, State or Local Government taxes relating to service charges, rooms tax or taxes on any products and/or services offered by Australian Pacific Lodges Pty Ltd.

3. DRIVER GUIDE POLICY

Driver/Guide subject to availability will receive 1 sole share bungalow at per person rate for accommodation and meals without single supplement charge. Additional driver guides accompanying trip will share where possible with Driver/Guide.

4. TERMS OF GROUP DEPOSITS/PAYMENTS

For all group DB&B rates offered. The wholesaler must notify the hotel by facsimile or by written notice of any cancellation or reduction, and agree that should the reservation be cancelled, the following charges will apply:

- (i). Up to 60 days prior to arrival: no penalty.
- (ii). At 60 days - a deposit of the first night's accommodation is required.
- (iii). Between 30-60 days prior to arrival: 50% of rooms may be cancelled. Space in excess of this amount is subject to one night's accommodation charge per number of rooms cancelled.
- (iv). Between 30-10 days prior to arrival: all room reductions/cancellations are subject to one night's accommodation charge per room cancelled.
- (v). Less than 10 days prior to arrival or no shows: full payment of accommodation charges applies.

5. FIT CANCELLATION POLICY

There will be no cancellation charge if the booking is cancelled 48 hours prior to arrival. Cancellation or no show within 48 hours, an overnight room cancellation charge will apply. Cancellations or no shows within 24 hours accommodation and full pre arranged meals or tours charge applies.

All SPECIAL RATE (HOT) offers different to rack rates, locals discounts and value adds require full payment at the time of booking, with no cancellation refunds available, change of dates of stay possible (SPECIAL OFFERS).
